## DIRECTIONS FOR USE

### General Use Restrictions

- Do not contaminate water, food, or foodstuffs. This product may be hazardous to aquatic invertebrates. Do not apply directly to water.
- It is recommended that a small, inconspicuous area be tested prior to treating an entire area in case of adverse effects.
- Do not apply to furniture
- Do not apply to pets
- Do not come in contact with any electrical wiring or mechanical parts of a meter.

### General Directions

Add contents into Orange Guard Home Pest Control spray bottle and follow specific directions below.

**Stream Setting:** Use Orange Guard Home Pest Control on the stream setting to penetrate into cracks and crevices or void spaces where insects may be living and breeding. Apply product directly into the crack, crevice, or void. Spray pests directly if possible. Wait a minimum of 3 minutes and wipe excess product with a sponge or cloth. Reapply if pests continue to be a problem.

**Spray setting:** Use Orange Guard Home Pest Control on the spray setting for larger pest gatherings and larger areas (such as inside garbage cans or behind stove and fridge). Spray product within 20-40 cm of the targeted pest, pest area, and larger voids/holes. Spray pests until they are visibly wet. Wait a minimum of 3 minutes and wipe excess product with a sponge or cloth. Reapply if pests continue to be a problem.

### Indoor Treatments:

**For Use In The Following Indoor Sites:** Apartments and Homes.

**Food Storage Areas, and Kitchens:** Includes areas for storage, preparing, and waste storage. Serving areas (when food is exposed) are also considered food areas. (NOTE: Exposed food must be covered or removed.)

Apply directly into cracks, crevices, voids or onto surfaces where insects are found. Apply to different elements of construction; between equipment and floor; openings leading to hollow spaces in walls; table legs and bases; and where insects hide or rest. Do not apply directly to food. Foods should be removed or covered during treatment. All food processing surfaces and equipment should be covered during treatment or thoroughly washed with an effective cleaning compound followed by a potable water rinse before using.

**Non-Food Areas:** Includes areas such as garbage rooms, bathrooms, floor drains (to sewers), entries and vestibules, offices, garages, closets and storage areas.

Apply to surfaces such as baseboards, under elements of construction, into cracks and crevices. Spray doorways, window frames, cracks and crevices where insects can enter or are harbouring. Spray surfaces until visibly wet.

### Pests:

**Ants, Cluster Flies, Cockroaches, and House Flies:** Using the stream setting and/or spray setting, apply into cracks, crevices, void spaces, and/or under objects where insects may be hiding. These areas may include, but are not limited to, openings around pipes and sinks; under appliances such as refrigerators, washing machines, and stoves; behind baseboards; cabinets; and floor drains. Reapply if pests continue to be a problem.

**Fleas:** Do not apply to pets. Use the spray setting tilted away from your face and, with a sweeping side-to-side motion, to kill adult fleas in dog and cat bedding and under furniture. Before spraying, test an inconspicuous corner of pet bedding or flooring for staining. Reapply if pests continue to be a problem.

**Ants:** Using the spray, apply directly to ants. Follow ant trails to outside and spray where they are entering the premises following the directions under “Outdoors On the Exterior Surfaces of Buildings”. Reapply if pests continue to be a problem.

**For Active and Hibernating Stages of Cluster Flies:** Using the stream setting, apply to crack and crevices and/or void where cluster flies may be congregating or hibernating. Infested areas may include, but are not limited to, cracks and crevices; wall voids; and around window and door frames. Reapply if pests continue to be a problem.

#### **OUTDOORS ON THE EXTERIOR SURFACES OF BUILDINGS**

Ants, cluster flies, fleas and house flies: Using the stream setting, apply Orange Guard Home Pest Control into cracks and crevices and/or voids where insects may be entering premises. Areas to be treated may include, but are not limited to, weep holes; under siding; soffits; around attic vents; and cracks and crevices and openings around windows, doors and pipes. Reapply if pests continue to be a problem

### **STORAGE & DISPOSAL**

#### **STORAGE**

To prevent contamination, store this product away from food or feed.

#### **DISPOSAL**

When container is empty, place in trash or offer for recycling if available. Do not reuse this container. For information on the disposal of unused, unwanted product and the cleanup of spills, contact the provincial regulatory agency or the manufacturer.

### **PRECAUTIONS KEEP OUT OF REACH OF CHILDREN**

Potential skin sensitizer. DO NOT get in eyes, on skin or on clothing. Wash thoroughly with soap and water after handling. For spot treatment, apply close to the surface and do not spray in the air.

Do not enter or allow re-entry of people/children/pets to treated areas until surfaces are dry and the areas are thoroughly ventilated.

### **FIRST AID**

**IF SWALLOWED:** Call a poison control centre or doctor immediately for treatment advice. Do not induce vomiting unless told to do so by a poison control centre or doctor. Do not give **any** liquid to the person. Do not give anything by mouth to an unconscious person.

**IF ON SKIN OR CLOTHING:** Take off contaminated clothing. Rinse skin immediately with plenty of water for 15 –20 minutes. Call a poison control centre or doctor for treatment advice.

**IF IN EYES:** Hold eye open and rinse slowly and gently with water for 15 - 20 minutes. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eye. Call a poison control centre or doctor for treatment advice.

**IF INHALED:** Move person to fresh air. If person is not breathing, call 911 or an ambulance, then give artificial respiration, preferably by mouth-to-mouth, if possible. Call a poison control centre or doctor for further treatment advice.

Take container, label or product name and Pest Control Product Registration Number with you when seeking medical attention.
